I understand all board must be paid monthly in advance. *The Dude Ranch* has the right of lien as set forth in the law in the state of Colorado, for the amount due for board and shall have the right, without process of law to retain said horse(s) until the indebtedness is satisfactorily paid in full.

*The Dude Ranch* shall not be liable for any sickness, injury, theft or death of said horse(s). All risks are assumed by the owner. The owner agrees to hold *The Dude Ranch* harmless from any loss or injury said horse(s). The owner is responsible for all costs, no matter how catastrophic, connected with boarding.

Owner agrees to hold *The Dude Ranch* harmless from any claim caused by said horse(s), and agrees to pay legal fees incurred by *The Dude Ranch* in defense of a claim resulting from damage by said horse(s).

If medical treatment is needed, *The Dude Ranch* will attempt to contact the owner and/or emergency contact. In the event the owner is not reached, *The Dude Ranch* has the authority to secure emergency veterinary and/or blacksmith care. Owner is responsible to pay off all costs relating to this care. *The Dude Ranch* is authorized to act as owner's agent to arrange billing to the owner.

The monthly board will be as follows and is due on or before the 5th day of each month. A late fee of \$5.00 a day will incur for every day after the 5th of the month. If past 60 days, legal action will be taken to have you removed from *The Dude Ranch*. Thirty (30) days written notice is required for change of boarding status.

\$250.00 (Pasture board)-includes free choice hay and heated water tank.

\$300.00 (Stall, no run)-Includes hay fed twice per day, heated water tank, grain and supplements fed once per day (supplements must be provided by owner and bagged for each horse), turnout 2 days a week (dependent on weather)

\$400.00 (Stall with attached run)-Includes hay fed twice per day, heated water tank, grain and supplements fed once per day (supplements must be provided by owner and bagged for each horse), turnout 2 days (dependent on weather).

**\*\*NO STALLIONS\*\*      \*\*Owner must provide verification of vaccinations and deworming twice a year\*\***
